Calcium Hypochlorite-50400 TPA, Stable Bleaching Powder- 30600 TPA, Sulphuric Acid-216000 TPA, Monochloro acetic acid-6000 TPA, Bromine-65000 Kgs, Hydrogen Gas-6480000 Cu.M. Sodium Hydride-720 TPA, Sodium Methoxide-2160 TPA, Wind Power Generation 11.25 MW and 10 MW Thermal Captive Power Plant.

The Chemical Plant facility is situated at Gondiparla (Village), Kurnool District, Andhra Pradesh. Bromine Plant is located at Tiruporur, Anna District, Tamilnadu. Wind Power Generation is located at Udayathur Theni in TamilNadu State.

7. TECHNOLOGY:

SRHHL has developed the product "Calcium hypochlorite" with own in-house, indigenous R&D efforts based on Sodium Process which is most cost efficient and environmental friendly. The Calcium hypo plant is first of its kind in India. The product is in the form granules containing chlorine of 65% to 70%. The quality of the product is well accepted by all our international customers.

8.MARKETING:

SRHHL plant is ideally located for its marketing. Monochloroacetic Acid & Sulphuric Acid find close market at nearby Hyderabad, where Pharmaceutical Industry is concentrated. Other Products also find within reach market. As the majority of the products are for
